PARENTAL RULES AND REGULATIONS

Having attended the registration meeting or having been informed by an OLA Athletic Association representative, we, the parents, understand that we are required to abide by the following rules:

1. When attending **any** games involving OLA teams we are to refrain from harassing any official, opposing coach, opposing fan or opposing player.
2. When attending **any** games involving OLA teams we are to refrain from harassing our own coach, fan or players.
3. We understand that if we need to talk to our child’s coach concerning any problems we will do this at an appropriate time. **This means that we will call the coach to set up a time to talk. It will not be before or after a game.**
4. We agree not to go outside of the association to handle problems but will instead come to a meeting of the Athletic Association for proper discussion.
5. We agree to work the time slot designated to us to cover concession, gate or security at our home site or at LCHS. If we cannot work that time it is our responsibility to have someone cover our time. We understand that if we do not show up or recruit someone during our time we will be fined \$5 per hour, and that our child is ineligible for participation until this fine is paid.
6. **REGISTRATION FEES ARE NON-REFUNDABLE AND MUST BE PAID BY OR BEFORE THE FIRST SCHEDULED PRACTICE. NO CHILD WILL BE ELIGIBLE TO PARTICIPATE IF ALL REGISTRATION FEES ARE NOT PAID.**
7. We agree to respect the rules of all facilities used for OLA games and practices whether home or away. We understand that we as parents are responsible for our families’ behavior at these facilities and are subject to league enforcement or discipline for violation of facility rules.
8. Finally, we understand that it is our responsibility to have our child to practice on time and, **most importantly, to pick our child up on time.** We realize that our team’s coaches have already sacrificed their time and do not need to be away from their families extra time due to us. If occasions arise where we have a schedule conflict we will show respect to the coach by calling them ahead to let them know.
(note: all children will be inside the gym until parents pick them up)

We understand and agree to all of the above rules and guidelines and agree that any violation on our, the parents, part should be investigated by the OLA Athletic Association. We then agree to abide by any penalties the association administers, most likely a one game suspension from attending our child’s competition. We also agree that if problems continue to occur, our family’s opportunity to participate in the association will likely be denied.

REGISTRATION

All registration forms must be turned in no later than **Wednesday, September 9, 2009**. These forms may be turned into the school office.

BOYS' BASKETBALL

The Lancaster Boys CYO defines the "Levels of Play" as follows:

- Varsity*** comprised of the program's most skilled players
- Intermediate 1*** comprised of 7th and 8th graders who do not play Varsity
- Junior Varsity*** comprised of most skilled 5th and 6th grade players
- Intermediate 2*** comprised of 5th and 6th grade players who do not play JV
- Novice 1 & 2*** comprised of 3rd and 4th graders

GIRLS' BASKETBALL

The Lancaster Girls CYO defines the "Levels of Play" as follows:

- Varsity*** competitive program for 8th grade or lower
- Intermediate 1*** competitive/instructional program for 8th grade or lower
- Novice 1*** instructional program for 5th grade or lower

PLEASE NOTE:

With all three programs, we must have completed registrations before we can determine how many teams we will be able to fill each year. We will do our best to have each child on the team that best suits his/her skill level, and will develop their talent.

Basketball games are scheduled to begin in December. Practices will begin after November 1. Open gyms may be scheduled in mid-October to allow the coaches to observe the athletes and determine playing levels.

Before the first official practice of the season, the coach should schedule a parent's night to review coaching philosophy, practice schedules, and give parents an opportunity to meet the coach and ask questions.
